Through **AGBC&TS**, we intend to educate all students and the knowledge gained over years of service and experience is used to help fulfill the degree program entered. All documented learning and experiences are assessed and compared to the requirements of the degree program selected. In some cases, this alone may satisfy the credit requirements of the selected degree program. However, depending upon the degree level, all students will need to do a Senior Paper, a Master's Thesis, or a Doctoral Dissertation.

All of this may be completed in a much shorter time and at a fraction of the cost than it would at many of the larger colleges and universities. Based upon available scholarships and discounts, tuitions may vary. Perhaps, one of our other services or programs may be what you're looking for. If not, perhaps we may be of service in helping you find the right institution.

THE APPLICATION PROCESS

When submitting or mailing your application, you will also need to supply the following items:

- Completed application
- 2 forms of I.D. (ex: driver's license & social security card)
- A brief biography listing all Christian and secular accomplishments.
- Copies of all degrees, transcripts, certificates, and other documentation.

Upon receipt of your application form and the other requested items, they will be assessed and compared with the requirements necessary to complete the degree program selected. Any gaps will need to be filled in. A fee of 50.00 must accompany the application.

TRANSFER OF CREDITS

AGBC&TS will accept credits earned at any recognized university, college, or institution, if appropriate to the desired degree program. You will need to submit transcripts and/or records of classes taken. Unofficial/official copies of transcripts are acceptable for purposes of the application and are required before credit is granted toward the degree or certificate. The transferring of credit hours must be associated with the classes that are offered at AGBC in order to be considered. To send transcripts to another institution, there may be an administration fee.

ACCEPTANCE OF DEGREES

The value of any college degree is subjective; depending upon many circumstances, conditions and needs. Most universities, colleges, institutions, agencies, etc., have their own specific criteria as to the recognition and acceptability of transferred credits. Therefore, if a student is going to transfer credits, they would need to direct their questions to those institutions, or agencies as to the acceptance of credits.

ACADEMIC POLICIES

AGBC&TS reserves the right to immediately suspend or terminate a degree candidate for the following reasons:

- * Inappropriate /Non-Christian behavior (by discretion of President
- Falsification of records or work submitted for evaluation / assessment.
- Falsification of information to gain a discount, scholarship, or grant
- Plagiarism
- Nonpayment of tuition
- Non communication (one year of no response to inquiries)
- Use of the AGBC&TS degree and transcript for fraudulent purposes

STUDENT RECORDS / PRIVACY ACT

Student records, other than name, date of enrollment, degree program, and date of graduation, will not be released to a third party without the student's written permission. This also includes any government officials or organizations unless they have a warrant to do so.

TAX DEDUCTION FOR COURSES FEE

HOW CREDIT IS EARNED

All credit earned at AGBC&TS is based upon quarterly credit. Each certificate, diploma, degree, and major, at each level, has a required core curriculum, and a required number of degree majors and elective courses. These can be found on pages 15 through 20.

Some of the methods used to obtain credits include, but are not limited to, the following (this applies to both classroom and correspondence students):

- Transcript courses from other colleges, universities, and institutions.
- Certificates and licenses.
- Credit by examination (CLEP, PEP, ACT).
- Workshops, seminars, training programs, counseling programs, AA programs, etc.
- Prior learning experiences arising from nontraditional means in living, working, and professional environments.
- Correspondence courses.

TUITION

Unlike most institutions of higher education, AGBC&TS does not charge by the credit. Instead, there is a flat fee charged for each degree level. There are no hidden costs or unnecessary addons. *Fees are subject to change.

The tuition for each certificate and diploma program is as follows for 2025-2026:

For students who are unable to pay their full tuition in one installment, please notify us. We offer very affordable, interest-free payment plan options. Monthly payment arrangements can be made upon special request.

Please note: If monthly payments are not submitted within 15 days of the due date, and no prior communication has been made with the Finance Team, this may result in a registration hold, transcript hold, graduation hold, cancellation of class schedules, or suspension of student benefits.

If you are experiencing financial difficulties, we encourage you to reach out to a Student Services Representative to explore additional options and support.

- * All unpaid balances must be paid in full or arranged in order to reapply.
- * Honorary Doctorate for those interested starting at a donation of \$1200.
- * Grad fees will be charged even if you decide not to participate in graduation.

REFUND POLICY

* Note – All tuitions are considered as a financial seed sowed to promote non-traditional accredited Christian Education. Full refunds are available only after the first week of class. Students are required to pay all, or a portion, of their tuition and fees for any registered course unless enrollment is officially cancelled prior to the start of classes. If a student does cancel prior to the start of classes, 100% of tuition and fees paid will be refunded.

All academic program requirements and financial obligations must be met before any certificate, diploma, or degree will be awarded. A student may withdraw from a certificate, diploma or degree program at any time. However, we request that the intent be confirmed in writing.

Withdrawal or cancellation occurs on the calendar day that the withdrawal is requested by email or in person with an admin of the office. The school provides a pro-rated refund for students withdrawing within the first four weeks of classes during the fall and spring semesters. (i.e.) Before Classes Begin- 100%

ADMISSION REQUIREMENTS

GED PROGRAMS ARE NOW AVAILABLE CERTIFICATE AND DIPLOMA PROGRAMS

ASSOCIATE DEGREE PROGRAMS

For admission into the Associate's program, a candidate is required to have a high school diploma, a GED, or equivalent (22) high school credit units, or at the discretion of AGBC&TS.

BACHELOR'S DEGREE PROGRAMS

To enroll in the Bachelor's degree program, an Associate's degree, the completion of sixty (60) credits, or its equivalent is required.

MASTERS PROGRAM

Entrance into the Master's degree program requires a Bachelor's degree, the completion of 120 credits, or its equivalent.

DOCTORAL DEGREE PROGRAMS

For admission into the Doctoral degree program, a candidate must have a master's degree, the completion of at least 30 graduate level credits, or its equivalent.

SECOND LEVEL DOCTORATE DEGREE PROGRAM

For admission into the Second Level Doctoral program, a candidate must have a Doctoral degree, the completion of 30-45 graduate level credits, or its equivalent.

SENIOR PAPER, THESIS, AND DISSERTATION

Two copies of each senior paper, thesis, and/or dissertation will be required from the student. One copy will become the property of the school, and the other copy becomes the property of the student and will be returned after grading.

Senior Paper: Must be at least 10,000 words in length (app. 50 pages).

Master's Thesis: Must be at least 30,000 words in length (app. 100-120 pages).

Doctoral Dissertation: Must be at least 40,000 words in length (app. 160-200 pages).

Second Doctoral Dissertation: Must be at least 50,000 words in length (app. 200+ pages). All subject topics must first be approved. For guidelines on writing a Senior Paper, a master's Thesis, or a Doctoral Dissertation, professors will send them when paper is assigned or please let us know and we will send them to you.

WHAT THE MAJORS ARE ALL ABOUT

APPLIED THEOLOGY

The study of Applied Theology emphasizes the practical expression of biblical truth and Christian doctrine in the life of the believer, the Church, and society. This field bridges the gap between theological understanding and everyday practice, guiding students to live out their faith with integrity, conviction, and purpose. Areas of focus include ethics, leadership, discipleship, pastoral care, social responsibility, and community engagement.

Students are encouraged to examine how theology informs decision-making, shapes moral character, and directs the mission of the Church in a changing world. By integrating theological reflection with ministry application, this course equips students to serve effectively, applying sound doctrine to real-world challenges with both wisdom and compassion.

BIBLICAL STUDIES

The field of Biblical Studies focuses on the exploration and interpretation of the Sacred Scriptures, emphasizing the central themes and key narratives found in both the Old and New Testaments. Students examine God's redemptive work, the covenant relationship with humanity, and the prophetic, wisdom, and apostolic writings that shape the Christian faith.

Alongside these themes, Biblical Studies also addresses the major doctrines revealed in the Word of God, such as the doctrines of God, Christ, the Holy Spirit, salvation, the Church, and eschatology. Careful attention is given to the historical, cultural, and literary contexts of Scripture, as well as to methods of interpretation including hermeneutics and exegesis.

The aim of this field is not only to foster academic understanding, but also to encourage spiritual growth, strengthen faith, and prepare students for effective ministry, teaching, and service in the Church and beyond.

CHRISTIAN COUNSELING

Christian Counseling is the study and practice of applying biblical truths and Christian principles to the counseling process. This field explores how Scripture and faith provide guidance, healing, and restoration for individuals, families, and communities. Students examine the goals of Christian counseling, the spiritual and practical techniques employed to achieve those goals, and the integration of prayer, biblical wisdom, and pastoral care into counseling practice.

A key component of this discipline involves comparing and contrasting Christian counseling with secular approaches, highlighting both the similarities in method and the distinctive reliance on biblical authority, spiritual formation, and the work of the Holy Spirit. Ultimately, Christian counseling seeks to equip students to serve with compassion, discernment, and faith-based insight, helping others find wholeness and direction in Christ.

DIVINITY

The Courses of Divinity explore the very nature of God—His sovereignty, deity, and the ministry revealed through divine encounters. This field engages students in the systematic study of theology while also cultivating a deep sense of spirituality rooted in Scripture. Emphasis is placed on understanding God's character, His work in creation and redemption, and the ways divine revelation has shaped the faith and practice of the Church. Through this study, students gain both theological knowledge and spiritual formation, preparing them for ministry and a deeper walk with God. Students are also challenged to wrestle with complex theological questions, developing critical thinking skills

alongside spiritual discernment. Ultimately, the study of Divinity aims to equip future leaders with both intellectual depth and pastoral sensitivity, uniting head and heart in service to God and His people.

MINISTRY/ SACRAMENTAL

The Study of Ministry pertains to the work of the Lord, the life of His Church, and the service extended to God's people. This field examines both the spiritual and practical aspects of ministry, emphasizing the call to serve with humility, faithfulness, and excellence. Students receive training in the performance of ministerial duties, the responsibilities of leadership, and the pastoral care required to nurture and guide congregations.

Attention is also given to the sacraments of the Church—such as baptism, communion, marriage, and ordination preparing students to understand their theological significance and to administer them with reverence and integrity. In addition, the study explores the unique roles of both clergy and laity, highlighting how each contributes to the mission and growth of the Church through Word, worship, and sacrament.

SACRED MUSIC

This major is in the art of music to prepare students as directors, composers and conductors for verbal and non-verbal communication skills, musical/liturgical knowledge, a generosity of spiritual, systematic and philosophical things that aide in leading and engaging others in the dedication to maintaining the integrity of music authenticity. These courses are also concentrating in the sacredness of music development, tradition, and preparation of students for work in various denominations and professional platforms as they study both modern and historical liturgical traditions to enhance the work and discipline of sacred music.

LEADERSHIP

The Courses of Leadership are designed to develop and cultivate the essential skills of effective leadership within each student. These classes focus on building character, vision, and the practical abilities needed to guide others with wisdom and integrity. Emphasis is placed on servant leadership, decision-making, communication, and the stewardship of influence.

The time spent in these courses aims to awaken and shape the leader within, inspiring students to grow in excellence and purpose. Through both theoretical study and practical application, students are equipped to lead in ministry, community, and organizational settings, reflecting Christ-like leadership in all they do.

CONSTRUCTIVE THEOLOGY

The study of Constructive Theology through the sacraments explores the meaning, practice, and spiritual significance of the central acts of Christian faith. The sacraments serve as visible signs of God's grace, reminders of Christ's work of salvation, and pathways for the believer's growth in the Spirit. Students examine the biblical foundations, historical development, and contemporary practice of the Seven Sacraments of the Church: Baptism, Confirmation (Chrismation), Eucharist (Holy Communion), Penance (Confession/Reconciliation), Anointing of the Sick, Holy Orders, and Matrimony.

This course not only highlights the theological depth and devotional importance of the sacraments but also trains students to discern their role in worship, pastoral care, and communal life. Attention is given to the differences between the sacramental theology of the historic Church and the practices of the contemporary Church, allowing students to understand both continuity and change in application.

The ultimate goal of this study is to equip students with a clear understanding of sacramental theology, preparing them to apply these truths to personal faith, pastoral ministry, and the life of the Church in today's world.
